The school staff collaborates with detention staff in establishing ways to services students by one-on-one, small group instruction (5-6), virtual/telecommunication , block scheduling and students packets.

Teachers and tutoring services are provided to students seeking academic support through one-on-one help, professional visits, and additional support in the classroom.

Zooms sessions are scheduled with counselors when needed. We have hired a social worker who provides SEL mini lessons to small groups of students, and visits with some students one-on-one. We have hired a Holistic Wellness Counselor that meets with students one-one one and with small groups.

This may include student health and food services.

The district works in coordination with County administration at Juvenile and Adult Detention centers to provide needed or additional services based on student emotional needs.

Resources are made available through the County and shared with the staff. The Pima County Superintendent's Office provides Safe & Healthy training and resources for staff.

The Coutry's Healthy and Safe School Coordinator has also been made available to the district to help address additional staff needs.

Public input is limited by the constraints due to the location of the school within the Adult (Jail) and Juvenile Detention facility. Policies primarily must follow that of the County and Sheriff's Department, but input is welcomed by students, parents and staff and communicated with County Administration at both facilities. Quarterly letters are mailed to parents/guardians at both schools each school quarter, informing parents about the school program and its operation during COVID. Students with special services is also addressed in the letter with contact information.
