## ***TUSD Governing Board Appointment Process***

**Tucson, AZ** – At the October 16, 2019, Tucson Unified School District Governing Board meeting, the governing board voted unanimously not to submit names for consideration for the governing board vacancy left by the October 3, 2019, resignation of Mark Stegeman.

As per A.R.S. § 15-302(A)(3), “within thirty days after notification of a vacancy, the school district governing board **may** submit up to three names to the county school superintendent for consideration of an appointment to fill the vacancy. The county school superintendent is not required to appoint a governing board member from the list of names submitted by the governing board.”

Out of respect to the process, Pima County School Superintendent Dustin J. Williams will now review and consider any qualified candidate who is interested in filling the vacancy.

Qualified candidates who would like to be considered for the vacancy must submit an affidavit of qualification and candidate appointment questionnaire to the Pima County School Superintendent’s Office by October 24, 2019, at 5:00 pm. The application packet can be found at: <http://www.schools.pima.gov/elections>. The completed packet may be hand-delivered to our office at 200 N. Stone Ave. or emailed to [schools@schools.pima.gov](mailto:schools@schools.pima.gov).

All applications will be thoroughly reviewed and considered by the Superintendent and Chief Deputy. Superintendent Williams will announce his appointment on or before November 1, 2019.
