- 1. Shanee Page was appointed in May 2015 to a two-year term. Ms. Page was re-appointed in November 2016 by the Board of Supervisors for the remaining two-year term for the position. The position will be on the ballot in November 2018 for a regular, four-year term.
- 2. Roy Sixkiller did not seek election for a special, two-year term in November 2016 and resigned in December 2016. Elliott Bustamante was appointed on December 20, 2016. Mr. Bustamante's position will be on the November 2018 ballot for a regular, four-year term. Marlene Gonzales did not seek re-election in November 2016 and resigned in December 2016. Rosaleen Segundo was appointed on December 20, 2016. The position will be on the November 2018 ballot for a special, two-year term.
- 3. Carole Siegler was appointed by the Board of Supervisors for the special, two-year term in November 2016, replacing Sherri Silverberg who was initially appointed in February 2016. The position will be on the November 2018 ballot for a regular, four-year term.
- 4. Samuel Donaldson and Diane Purvis were appointed in December 2014. The Board of Supervisors re-appointed Mr. Donaldson and Ms. Purvis to an additional, two-year term in November 2016. These position will be on the November 2018 ballot for regular, four-year terms.
- 5. Susan Fry was appointed in July 2015 and was re-appointed by the Board of Supervisors in November 2016 for a special, two-year term. This position will be on the ballot in November 2018 for a regular, four-year term.
- 6. Marth Durkin was appointed in August 2015 for a special, two-year term. Mr. Gonzales was elected to replace Ms. Durkin in November 2016 for the special, two-year term. The position will be on the ballot in November 2018 for a regular, six-year term.

- 7. Sharon Nicholas passed away in May 2017. Mr. Hudecek was appointed by Superintendent Williams in July 2017. The position will be on the November 2018 ballot for a special, two-year term.
- 8. Sharon Niehaus resigned on June 15, 2017. Mr. Oesterle was appointed by Superintendent Williams in August 2017. The position will be on the November 2018 ballot for a regular, four-year term.
- 9. Jo Grant resigned on August 9, 2017. Ms. Zibrat was appointed by Superintendent Williams in September 2017. The position will be on the November 2018 ballot for a regular, four-year term.
